Effective December 1, 2019 Acadiana Medical Federal Credit Union dissolved our partnership with Hancock Whitney Bank (formally MidSouth Bank). AMFCU was unable to successfully negotiate a “no fee” for check cashing and ATM use for our members.

We are very happy to announce that we have partnered with Rayne State Bank. This partnership will allow our members with an AMFCU checking accounts access to **FREE** ATM use at any Rayne State Bank. SAVE THE DATE

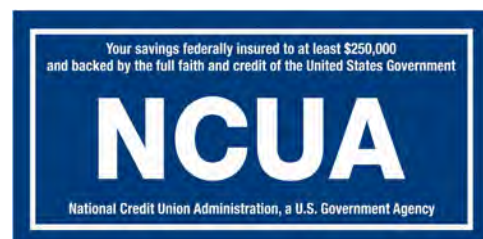

Identity Theft

Don't let it happen to you!

You read about it. You hear about it. But you never think it will happen to you. Identity theft is when someone steals your personal information to gain access to your money and open charge accounts in your name. In a very short time, a large debt can be created in your name. Identity theft can happen to anyone. The government estimates that over 400,000 people are victims of identity theft.

There are a number of things you can do to protect yourself.

> Don't give out your checking account, credit card or social security number unless you know exactly whom you are dealing with.

> Report lost or stolen credit and debit cards immediately.

> When you close a checking account, shred all unused checks.

> Don't carry your social security card with you.

> Protect your ATM Personal Identification Number (PIN.)

> Review statements for unauthorized charges.

> Never provide your personal information in response to an unsolicited telephone call, fax, letter, email, or internet advertisement.

Core Computer Conversion

On April 1, 2020, Acadiana Medical Federal Credit Union will change our computer processing system. We will be working hard to ensure that this conversion is completed with little interruption to you, our member owners. Although, this conversion will require that the credit union be closed for short periods of time. It is our goal to keep those times at a minimum.

Before choosing a new processor, we researched and spoke with other credit unions in our area. We believe the decision that we made to select ShareTec as our processor is one that will allow us to provide you with better and more convenient service.

Savings Withdrawals

January 1, 2020 will start a new year for withdrawals from your savings account. AMFCU allows 12 free withdrawals per calendar year. After the 12th withdrawal, a fee of \$5.00 will be charged for each additional withdrawal per calendar year. Open an AMFCU checking account and avoid withdrawal fees.
